2026 REGISTRATION AND COMPULSORY PAYMENTS

All trainees, parents and guardians are informed about the following compulsory minimum payments for the academic year 2026:

Description	Amount in N\$
1. Technology & Connectivity Fees	500
2. Personal Protective Equipment (PPE) (All trades, except Welding, Boiler and ICT)	1010
3. Training Material	1650
4. Personal Insurance	80
5. Sport and Culture	260
6. Student Card	50
7. External Assessment	490

NOTE: Kindly note that the ICT trainees do not pay for PPE while the PPE for Welding and Boiler Making trainees is N\$1,250.

The above-mentioned fees are not covered under the Subsidised Funding Model.

HOSTEL REGISTRATION AND FEES (2026)

- The hostel fee for the 2026 academic year is **N\$1,400 per month**.
- Hostel fees are **payable upfront** and are spread over **equal monthly instalments of N\$1,400**.
- A **once-off, non-refundable wear and tear fee of N\$250** is compulsory and must be paid **on or before the day of hostel registration**.
- Any **outstanding hostel fees from previous years** must be settled in full prior to hostel registration.
- Cash payments are not accepted** at WVTC. Payments must be made via:
 - Swipe at the Speed Points on campus,
 - Electronic Funds Transfer (EFT), or
 - Direct deposit into the WVTC bank account.
